Terms and Conditions

- 1 As a Member, Non Member or Guest of The Guelph Country Club I agree to abide by all rules of conduct and dress code. Inappropriate conduct will not be tolerated and could lead to the withdrawal of club privileges.
- 2 Club management and staff have the authority to enforce all rules and regulations.
- 3 The Club is not responsible for lost or stolen property. Please safeguard your personal possessions at all times. Your presence on the Club property is at your own risk.
- 4 Members or guests are responsible for damages to Club property that they have caused.
- 5 Any valid complaints should be submitted in writing to the Club President.
- 6 All curling fees are payable by October 1 each year. A 2% monthly service charge will apply to all overdue accounts. All \$12 guest fees are due before using the ice. Guests must be registered and fee paid at the bar.
- 7 All accounts 60 days in arrears will be reviewed by the Board of Directors which may result in suspension of playing privileges.
- 8 Arrears in fees from a previous year will result in a withdrawal of Club privileges until the account is brought into good standing.
- 9 Children in the Club must be supervised by an adult at all times.

- 1 I acknowledge that membership at the Guelph Country Club including curling and/or volunteering involves risk of personal damage or injury.
