Terms and Conditions

- 1 As a Member, Non Member or Guest of The Guelph Country Club I agree to abide by all rules of conduct and dress code. Inappropriate conduct will not be tolerated and could lead to the withdrawal of club privileges.

- 6 All curling fees are payable by October 1 each year. A 2% monthly service charge will apply to all overdue accounts. All \$12 guest fees are due before using the ice. Guests must be registered and fee paid at the bar.
- 7 All accounts 60 days in arrears will be reviewed by the Board of Directors which may result in suspension of playing privileges.
- 8 Arrears in fees from a previous year will result in a withdrawal of Club privileges until the account is brought into good standing.
- 9 Children in the Club must be supervised by an adult at all times.
